# 2020 *State of the School*

Dear CCS Community:

The start of our 25th year, the 2020-2021 school year, has been like no other for CCS. COVID-19 changed the way we are able to be together in extreme ways. Decisions had to be made about face coverings, physical distancing, movement, recess, lunch, technology, and the education of our students.

In order to get the school ready for our return we had many unforeseen expenses that were not in our original budget. We were fortunate to work with Albemarle County Schools to help process our share of the CARES Act monies. CCS was allotted just over \$20,000. That money was used to purchase microphones and cameras so that we are able to offer synchronous learning opportunities for students. CARES money also allowed us to buy podiums and rolling carts for each teacher to move between classrooms. All of these are instrumental in ensuring we can do what is needed for in-person and synchronous instruction. In addition, we received a private donation that allowed us to upgrade the chapel by providing an AV system that will allow us to stream Mass to all students in their classrooms each Friday.

Even with the generous donations, and the CARES Act funds, CCS has spent approximately another \$40,000 thus far. This has been done to ensure we are meeting CDC, VDH, Thomas Jefferson Health District, and Diocesan guidelines. Those funds covered paint for outdoor physical distance dots, decals for physical distance dots in the building, air purifiers for each classroom and office, thermometers, PPE, additional sanitizer, increased cleaning supplies, textbooks, computers, math manipulatives, and various other miscellaneous expenditures. All of this was necessary in order for us to re-open safely, ensuring we met our health mitigation plan requirements. In addition to the money spent above, we also added 4 full time assistants to ensure we could create classroom spaces that maintained a 6-foot physical distance and were monitored at all times.

As in every year, enrollment plays the biggest part in our ability to offer our programming. To begin this year we had 302 students. 252 of our students are in-person and 50 are utilizing our synchronous learning option. Our decision to maintain physical distances within the classroom has also resulted in the limiting of enrollment. In a typical year, we would accept 40 students per grade in K-8. This year however, we have limited enrollment in grade levels. This decision has resulted in a waitlist for most grades.





Within the building, we have taken many steps to do our best to ensure that the students and staff are safe. Before we returned, I surveyed parents and staff and it was clear that a 6 foot distance indoors was imperative. Therefore, in JK-5 there are no more than 12 students in a classroom. Because of enrollment numbers, in grades 2-5 we had to split the classes into 3 cohorts utilizing our additional assistants. This is a major change from our typical 2 classes per grade structure. In MS, we have started the year with whole group instruction in our largest areas of the school: the gym, cafeteria, and STEAM labs.

Students do not move but rather the teachers go from room to room.

We have at least one student per grade level accessing instruction synchronously. This new way to teach does require our teachers to put in more time to plan, prepare, and teach. They participated in professional development this summer in order to strengthen their knowledge regarding best practices and engagement during these unprecedented times. They are adapting quickly to our new normal, and making sure they are still delivering the quality Catholic education that you have come to expect. While there have been some technical glitches, we feel we are being very successful thus far.

One big change for everyone is the requirement of face coverings. Everyone is required to wear a face covering when they are in the building and cannot be alone in a classroom or office. Teachers may give small face covering breaks within the classroom and we are trying to provide several opportunities a day to be outside. Once outside, if students are more than 6 feet apart from one another they are also allowed to remove their face coverings.

Another major change was to carline. Middle school students are dropped on the lower blacktop at the back of the school while JK-5 remains in our normal carline drop-off zone. Every student has their temperature checked before they are allowed to enter the building. If there is an elevated temperature check by the staff, Nurse Weber does a secondary check with a more accurate inner ear thermometer. We are also checking for COVID symptoms daily. If a student is showing symptoms or has an elevated temperature, we are recommending that they see their pediatrician. Students and staff are required to be fever-free without medication for 24 hours before they return to school. COVID related illnesses, including positive tests, are dealt with on a case by case basis in conjunction with the Thomas Jefferson Health District and the Diocese of Richmond.

COVID-19 has also had an impact on our community events. Last Spring we had to cancel the Gala-Auction, holding a small portion of it online. This year, we have already postponed our annual 5K until 2021, as well as our Back to School Picnic. We proceeded with our golf tournament on September 28th, and are planning for the return of the Gala in the spring.





The faculty and staff has worked hard to ensure that we are able to remain in person this school year. It means the world to us to have students back in the building. Everyone is having to work harder than they ever have before. Both students and teachers, whether in-person or synchronous, have had to work together to establish new norms and help one another in our new normal.

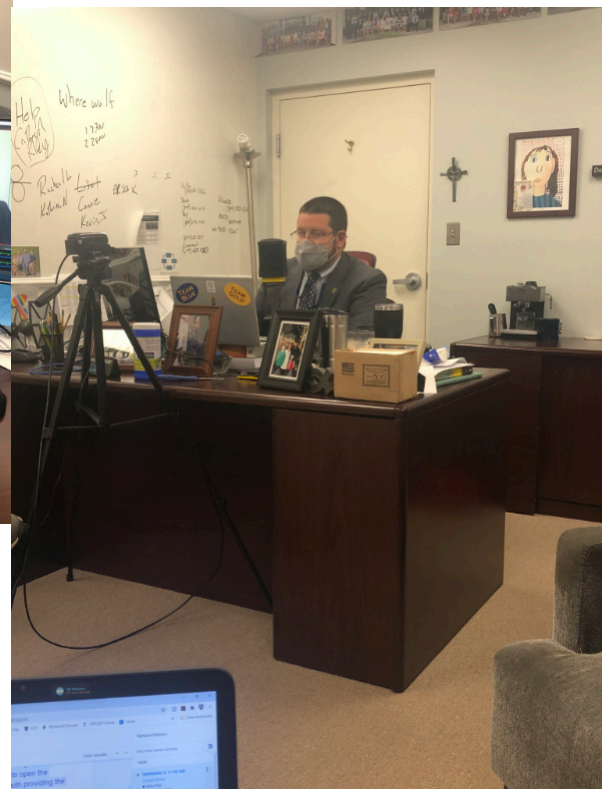

## *Athletics & Extracurricular Clubs*

Although all athletics and extracurricular club activities were suspended in March, we were still able to have a vibrant boys' and girls' cross country, boy's soccer, girls' volleyball, and boys' and girls' basketball team. Clubs include tennis, golf, youth basketball, rosary, sign language, scouting, cooking, drama, worship choir, robotics and jam band.

Boy Scouts of America and Girl Scouts of America are both well supported at CCS. In 2019-20 our CCS Girl Scout Troop had 17 members in kindergarten – sixth grade. Our Boy Scout Troup had 25 active scouts in kindergarten – fifth grade. Scouting supports the mission of CCS by providing students with opportunities for stewardship and leadership.

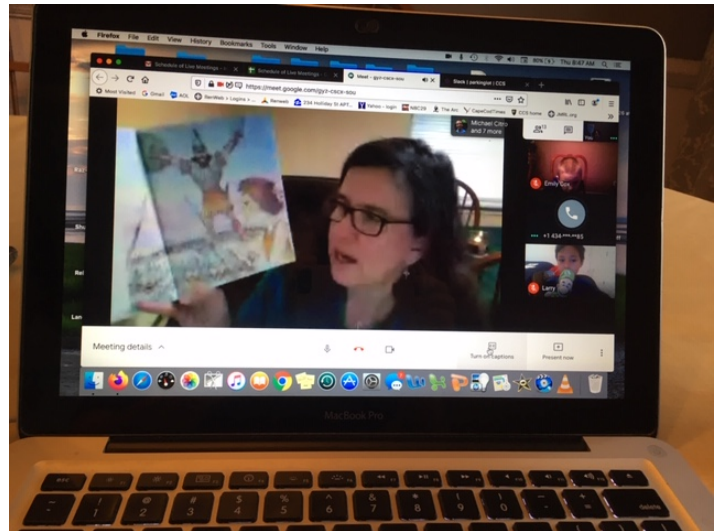


# Distance & Virtual Learning

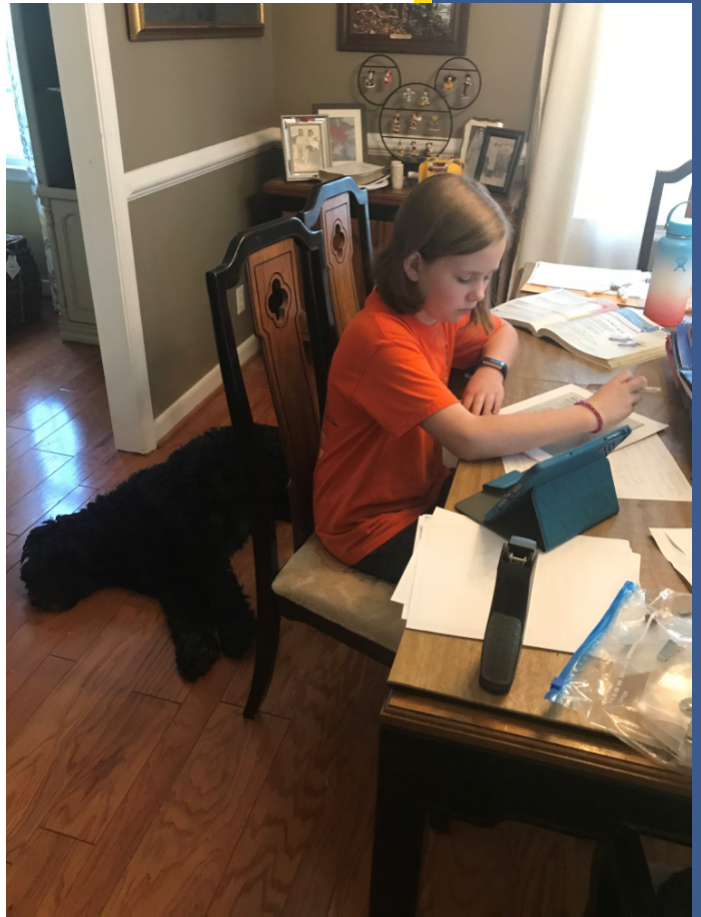
On Friday, March 13, 2020, a State of Emergency was declared in the Commonwealth of Virginia in the face of the COVID-19 pandemic. Schools in Charlottesville City and Albemarle County closed for what they thought would be a short two-week period. By the end of that two weeks, Governor Northam made the decision that all schools in Virginia would remain closed through the end of the 2019-2020 school year, and so what was meant to be a temporary Distance & Virtual Learning plan became our way of life for the remainder of the semester.

Charlottesville Catholic School has always been known for its amazing educators who constantly step up in times of need, and this time was no different. They rose to the challenge of transitioning to the digital classroom, successfully developed grade-specific plans that addressed Diocesan Consensus Curriculum standards, and continued to Ensure that students received a quality Catholic education in CCS fashion.

While many of our early-spring events unfortunately had to be cancelled (including the Readathon overnight and the 24th Annual Gala Auction), we were determined to end The year on as normal a note as possible. Field Day, the End of Year awards ceremony, and the annual Art Show all became virtual events. By mid-June, we were even able to hold an outdoor, socially distanced graduation ceremony for the Class of 2020.

# Alumni Spotlight

I'm not sure that I ever wanted to be a priest when I was still at CCS. Yet, looking back, there are innumerable lines that stretch between those days of school and my approaching ordination.

I was in one of the first few kindergarten classes at CCS, starting in '98 in the ACAC building off Four Seasons. It wasn't until my third grade year that we moved to the current school. At CCS, I first had religion classes, prepared for the sacraments, read at Mass. Now I study theology full time and will soon be administering those sacraments and saying the Mass. I remember well building a model church in the 7<sup>th</sup> grade and putting it up in the hallway outside the library. I was just then learning names like "ambo" or "lavabo," names for things I now use almost every day.

I always had an interest in math and science, which lasted through my years at Albemarle High School, but by the time I went off to college, I knew that I wanted to work with people. So in 2011, I went off to Franciscan University in Steubenville to study psychology, having it in mind to be a guide for others.

It was there at Franciscan that I discovered a desire to be not just a guide, but a shepherd, a father – a preacher and priest. I had known the Dominicans already, since I had always attended St. Thomas Aquinas parish, so I contacted them in sophomore year. Then I entered the Dominican Order in 2014, in the summer after graduation, and I haven't looked back. I made my solemn vows (until death) in 2019, and I was ordained a deacon just months ago, in March 2020.

Those lines that connect my years at CCS to my life now – they pull both ways. I didn't know then what I was being prepared for. Only God did. But as I approach ordination to the priesthood in May 2021, I know that CCS will remain in my prayers. My years there helped to make me who I am – a connection that can never be broken, a debt that can't be repaid.

## *Education Improvement Scholarships Tax Credits (EISTC) Program and Donations*

The Education Improvement Scholarships Tax Credits (EISTC) program is designed to allow families who traditionally could not afford private education the choice to do so. In Charlottesville, we are the only school eligible to receive donations through the McMahon Parater Foundation. Each gift allows us to find more students who qualify, both helping our enrollment and changing their lives.

Donations given between July 1, 2019 and June 30, 2020 allowed 55 students to attend CCS for the 2019-2020 school year at a discounted rate. The rate is determined by the locality in which they live, therefore the rate is different for each student. Money raised this fiscal year has increased the number of opportunities for children to attend our school. Each of these families is eternally grateful to this program, which allows them to make the decision to come here.

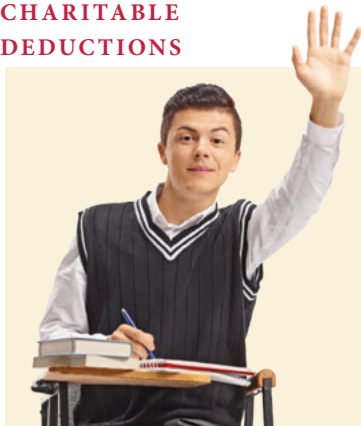
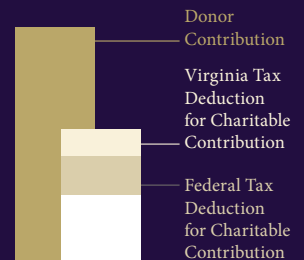
