## Social Studies

This week we learned about the Bill of Rights, and the ratification of the constitution. We will be learning about the start of political parties and how to read population density maps.

#### Math

This week we worked on multiplying whole numbers and mixed numbers, and using canceling to simplify prior to multiplying fractions. We will be learning about unit fractions.

\*Students will need to complete (mastery level) Khan Academy *Add and Subtract Fractions, Multiplying Fractions, and Algebraic Thinking* by the end of the 4th quarter.

\* Please practice the basic multiplication facts at home or in the car coming to and from school. Knowing your multiplication facts is a vital skill that students will be needing for success in math in school and in daily life.

# Language Arts/Reading/Writing

This week students took the ACRE test and focused on the Stations of the Cross. Next week, we will learn more about the Triduum and Easter.

## Science
