Hello,

My name is Joey Michel, and I was part of the CCS class of 2010; back when the closest thing to a "STEM Wing" we had was dissecting a chicken wing from a Kroger 12 pack. I am currently finishing up my foundational rotations as a 3rd year medical student at UVA. In many ways my path to becoming a physician, and more specifically a pediatrician, has roots in my time at CCS.

For example, with encouragement from Ms. Searforce I took a leap of faith to become the only guy in the choir, which was not the most socially secure spot for a quiet 11 year old. But without that influence, I may not have continued to pursue music throughout my education. In the end, it was peers in my college a cappella group that mentored me as I explored my interest in and committed to medicine, bringing me to where I am today.

What made you want to be a Pediatrician? When did you know?

I grew up in a medical family, so there is no denying that I may have had a little tunnel vision when considering what I wanted to do when I grew up. With that said, I entertained a variety of fields before finding my home in medicine. In high school, I was in the Math Engineering and Science Academy at Albemarle high school with thoughts of pursuing biomedical engineering. As I moved through high school, I realized that

my strengths lie in my ability to connect with and support people rather than in direct application of basic science. I entered college majoring in Kinesiology with thoughts of becoming a physical therapist. It wasn't until I took a Sociology of Healthcare course in my late 2nd year that I committed myself to medicine. It was there that I first explored social determinants of health and healthcare inequities. I remember sitting in the library early on a Sunday morning watching a documentary about the reactionary nature of our healthcare system and how preventative primary care was the solution. For the first time I felt a true calling, a vocation by all definitions. The career of a primary care physician consists of endless opportunities to support patients not only through prescriptions, but also by means of education and counseling. This chance to form long-term relationships with my patients to advance their health is what sparked a fire in me, and helps me get up in the morning when I have to go see patients in the hospital before the crack of dawn.

These opportunities for long-term preventative care are magnified in pediatrics. Everyday you are working to prevent health issues in the future and support the growth of remarkable kiddos. Growing up, I never had younger siblings, so in a way I feel like I'm drawn to the kids I've helped take care of as if I'm a protective older brother. I just want them to be happy and healthy. That could manifest as getting the antibiotics a child needs to cure an infection, being the first adult to use a young teen's preferred pronouns thereby reducing their risk of self-harm by half, or counseling a family about a new long term diagnosis. It's all about setting up that person for success in the long run. In short, the days I have experienced the most joy in medical school are the days I get to laugh with kids, and the days I've had the most meaning are when I get to support them and their families in times of uncertainty.

What was it like for you at Charlottesville Catholic? Did you have a favorite teacher?

Looking back, the teachers made my experience at CCS. I was a pretty sensitive kid, and the support that I got from them at every level helped me grow into the confident young man that I am today. Some all-stars that I would be remiss if I didn't give a shoutout include Ms. M, Mrs. McCormick, and Ms. Searforce. They seemed to identify the parts of me that I was insecure about and foster them to be strengths. My heart, my mind, and my voice were bolstered by their care and attention.

Did you feel prepared for high school? In what way?

I'm not going to lie, the transition from CCS to high school was challenging, but that is true of any transition. Academically, I found the expectations of my teachers at CCS set me up for success at Albemarle, especially when it came to the humanities. The biggest culture shock for me going from CCS to Albemarle was the tendency of some of my peers to not be respectful to our teachers. While I admit I griped about some of the rules and regulations of CCS while I was there, the level of respect shown to the faculty created an environment in which they respected and supported us as well. I will say, the challenge came with integrating into the public school system socially, and for that I have some advice; lean on your CCSers who come with you to highschool, join a sport or club early to meet new people and branch out, and pursue what you like to do regardless of what others think.

What words of advice do you have for our students?

- 1. Live your life with the attitude that everyone around you could be having a bad day, and your energy and warmth could be the thing that turns it around. So be kind, considerate, and a light to others.
- 2. Don't be afraid to express yourself. You have endless possibilities ahead of you and your belief in yourself is one of the only things in your way.
- 3. While it is important to study hard and think of the next steps, try not to get too worked up about the ifs, ands, or buts. You are going to make a lot of decisions in your life, some right and some wrong, but the most important thing is to take stock of the present moment and how you can be your best self in the now.











Charlottesville Catholic School could not be more proud of 6th grade student, Olivia Goodwin, who was recognized National Athlete of the Year by Virginia Commonwealth Games. She was further nominated for the National Congress of State Games (NCSG) Athlete of the Year award. Virginia was honored for the 3rd time in the last 5 years to have one of the national winners. Congratulations Olivia!

Olivia Goodwin, 11, swims for the absolute love of the sport. Being in the pool is not something she takes for granted, as she was born with a congenital heart defect. Olivia is already on her third pacemaker, causing consistency in the pool to be challenging. Often times, she had been peaking in her swimming only to need heart surgery and end up out of the water for six months. Following surgery, it takes her about another six months to get back to her preoperation weight and performance level. Overall, it can be very frustrating for someone who simply wants to swim and train. Olivia understands that her medical issues are part of her story, but she never uses it as an excuse. She continues to swim, work hard, and believes that one day she will place in an event. The sport of swimming has also given her discipline, organization, and time management skills; all of which are keys to being a successful adult. It has also taught her sportsmanship, teamwork, and how to be humble. This is visible as Olivia attends her younger sisters swim meets and as they do well and succeed. Olivia cheers them on and does not dwell on the fact that she has a pacemaker and they do not. Olivia's triumphs are not awards on the podium; they are completing a 500-meter freestyle exactly a year after heart surgery and competing in events even though she knew she would come in last place. Olivia embodies the spirit and drive of competition and always strives for excellence, no matter what obstacles may be in the way.

CHARLOTTESVILLE, Va. (CBS19 NEWS) -- A local 11-year-old is being recognized across the state for her win at an Olympic-style competition.

Olivia Goodwin won the Youth Female Athlete of the Year at the Commonwealth Games. The competition is modeled after the Olympics and welcomes all athletes regardless of age or skill level.

Goodwin has been swimming most of her life and says the water feels like home. The sixth-grader is always striving for excellence; no matter what's in her way.

Goodwin swam in the 500M-free exactly one year after having heart surgery; she's now

on her third pacemaker.

She said her obstacles inspire her to keep going. "There's a fire in me, I know that I'm different, but if you love something, just do it. Just keep on going," said Goodwin.

Her heart condition interferes with practice and during peak performance. It can be frustrating at times, but she said it doesn't define her and made her who she is today.

Goodwin's determination and grit inspire those around her, especially her family.

"She is the rock of the family, no matter how tough things can be there's always something to be thankful for," said Olivia's mother, Marissa Goodwin.

Olivia's heart is that of a champion. She believes that anyone can do anything.

"Just keep persevering and follow your dreams," she said.

Her hard work has also inspired her two younger

sisters to follow in her footsteps, and Olivia is proud to cheer them on.
